Re: Lot Code Format Update

Bulk Products Code Format: PPPYYDDD99

- P** identifies the packaging plant (see list of identifiers below)
- Y** identifies the last two digits of the year
- D** identifies the Julian day of the year
- 99** identifies the numeric sequential number for the day

Example: CRK2027404

Packaged Products Code Format: PPPYYDDDN

- P** identifies the packaging plant
- Y** identifies the last two digits of the year
- D** identifies the Julian day of the year
- N** a single digit number that identifies the source (bulk) lot for this lot – used by co-packers

Example: CRK20274 or SF220274-2

Note:

Sugar Producers: There should be no spaces between characters in the lot code. However, materials packaged by sugar producers may have numbers or letters following the “DDD.” There should be a space between the lot code and these additional characters. These designations provide information for the producing plant and are **not** a part of the lot identity.

Co-packers: Materials packaged by co-packers may have a dash and a number following the “DDD.” These tie the lot to a specific source lot and **are** a part of the lot identity.
